
# The filing deadline for FY20 is approaching! Get your CbC reporting done in 3 easy


# Preview the validated data and create exports in an XML format

#### Submit your CbCR XML report


Once all the previous steps have been finalized, TPcbc allows users to use the XML for local CbCR filing in 20+ OECD Member States. For entities that report in the Netherlands, TPcbc allows direct reporting to the Dutch revenue authorities. A receipt will be generated after the report has been successfully finalized.

- Basic: CbCR report in an XML format (20+ OECD Member State formats)
- Add-on feature for CbCR filing in the Netherlands
  - Visualization of data sent to the Dutch tax authorities
  - Identification number of the request
  - Actual XML data that was sent to the tax authorities
