About MDR/DAC6

On 25 May 2018, the Council of the European Union adopted a Council Directive ("Directive") introducing mandatory disclosure rules for intermediaries such as lawyers, accountants, and tax advisors. This Directive obliges intermediaries to report:

- Potentially aggressive tax planning arrangement(s) ("Arrangement" or "Arrangements")) with a cross-border dimension; and
- Arrangements designed to circumvent reporting requirements like the Common Reporting Standard ("CRS") and Ultimate Beneficial Owner ("UBO") reporting.

EU Member States' tax authorities will exchange the reported information automatically within the EU through a centralized database.

How it started

TaxModel has been approached several times by intermediaries, asking whether we already have an MDR tool available, or are still developing such a solution. After all, we have the people, knowledge, expertise, and experience to develop best practice software solutions.

Enabling MDR compliance

To assist intermediaries in fulfilling their obligations, our MDR/DAC software tool can supply the following assistance:

- Secure coordination of all communications (regardless format) and reporting
- Control timing of reporting
- Make reportable transaction and building blocks transparent for the client, all intermediaries, and other stakeholders
- Ensure consistency in information
- Data repository for documentation to be reported, proof of reporting, etc.
- Coordinated reporting
- To monitor workflows and who reports what and when
- Comfort for the client that all is coordinated, who is involved and what is exactly reported
